## Summer Safety Tips:



- Apply sunscreen with an SPF of at least 15 .

Dear Residents,

Many new and exciting projects are occurring in Boston Heights this year.

- Akron Cleveland Road, South of Rt. 303, bridge replacement project to be completed— Ribbon cutting set for 11:00 AM, Friday, July 17, 2015.
- Due to the unusually harsh winter, some of our roads will require repair this year ahead of their scheduled resurfacing dates.
- Arhaus Furniture World Headquarters building, parking and landscape construction continues towards opening late Fall 2015.
- Marketplace roadway project heads toward completion for new Bass Pro Shop, Costco and future retail out lots.
- Hines Hill Road improvements between Olde Eight Road and new Rt. 8 will commence in July for completion late Fall 2015.
- Mainline waterline linking Olde Eight waterline to Hines Hill Rd, waterlines are completed with waterline tie-ins to follow later this year.
- Side street waterlines on Beverly Road, Grandview Drive, Richard Road, Sholle Drive and Wolcott Drive to begin installation. Home waterline tie-ins to follow the side street waterline installations.
- Akron Cleveland Road, Ledgeview Drive, Ianwood Circle, Rockwood Circle, Wooded View Drive, Pinewood Drive, Pinewood Court, Parkside Court, Meghan's Lane, Beverly Road, Grandview Drive, Richard Road, Sholle Drive and Wolcott Drive are all scheduled for the Village 2016 resurfacing project.
- Olde Eight Road drainage crossover pipe replacements began this year in preparation for Olde Eight Road resurfacing in 2017.
- West Boston Mills Road is scheduled for reconstruction [with OPWC grant application] for 2019.

The projects shown to be completed over the next few years are partially funded by grant dollars applied for by Village Engineer, David Krock of OHM Advisors [formerly KEE, Krock Esser Engineering]. Income from the new projects in the Village, which is being used for these infrastructure upgrades, can be attributed to guidance the Village received from Village Solicitor Marshal Pitchford, Justin Markey with Roetzel and Brian Cooper of Columbus based ACI Financial Advisors. I wish to thank these professionals as well as Village Council Members and Planning & BZA Commissions for working together with me to achieve growth in sustaining this community well into the future for the Village of Boston Heights.

## From the office of the Fiscal Officer

- **Motor Vehicle License Tax:**

Next time you register your license plate at the License Bureau, don't forget to emphasize that you live in **BOSTON HEIGHTS**.

- **New Ordinance Passed:**

In May Village Council passed **Ordinance 2015-3-5** "requiring persons or companies wishing to distribute commercial literature, non-commercial literature, and newspapers to register with The Village Fiscal Officer prior to the distribution of any such material. the Village will maintain the appropriate level of safety and the amount of paper waste will be minimized. The entire Ordinance is online or available upon request.

- **Homestead Exemption ( Property Tax)**

1. A homestead exemption, or a homestead deduction, is a form of property tax relief given to qualified residents on their primary home property.
2. Who qualifies for the Homestead Exemption?
3. Homeowners over the age of 65;
4. Homeowners under the age of 65 on permanent or total disability;
5. Military Veterans who are evaluated at 100% disability from a service-connected disability;
6. Homeowners who are already receiving the Homestead Exemption and who currently changed address.
